I , CS Bharat Rathore (ACS: 48426) proprietor of M/s Bharat Rathore & Associates, Company Secretaries, Kota The Board of Directors of Chambal Breweries and Distilleries Limited at its meeting held on , 10th August, 2022, has appointed me as the scrutinizer for the remote e-voting process as well as to scrutinize the physical ballot forms to be received from the Shareholders at the venue of the AGM pursuant to Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and in accordance with Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.



Adroit Corporate Services P Ltd is the Registrar and Share Transfer Agents (hereinafter referred to as "RTA") of the Company.

The internal cut-off date for the dispatch of the Notice of the AGM was 19th August 2022 and as on that date, there were 3615 shareholders of the Company. The Company had sent the Notices of the AGM along with Annual Report and E-Voting details by e-mail to 1715 shareholders whose e-mail IDs were made available by the two Depositories and for those shareholders, holding shares in physical form, who had registered their email IDs with the RTA. In respect of 2380 shareholders (out of which 1901 shareholders whose e-

mail IDs were not available and 479 cases where shareholders e-mail IDs were available but they opted for physical copies also), notices were sent by courier.

The Company completed the dispatch of the notices to the Shareholders by Thursday, 25th August, 2022.

As prescribed in clause (v) of sub rule 4 of Rule 20 of The Companies (Management and Administration) Rules, 2014, the Company also released an advertisement, which was published more than 21 days before the date of the AGM in "The Indian Express" English newspaper in English language and in "Rashtradoot" Vernacular newspaper in Vernacular language on 26th August, 2022. The notice published in the newspaper carried the required information as specified in Sub Rule 4(v) (a) to (h) of the said Rule 20.

At the venue of the AGM of the Company, the facility to vote through ballot paper was provided to facilitate those Shareholders present in the meeting but could not participate in the Remote e-voting to record their votes. There were no votes cast at the venue of the AGM through ballot paper.
